### Job description

- Full-time teacher of ICT for the secondary school
- 15-20 weekly periods (45 minutes)
- Lessons to pupils of mixed language groups

### Profile

- Command of English and/or French at mother tongue level
- University degree and authorization to teach ICT in the secondary school at all levels
- Experience of teaching ICT at the secondary level
- Knowledge of a second working language (English/French/German) is an asset
- Ability to work in an international environment and to cooperate with colleagues and management

### Conditions

We offer a two years contract. This contract is renewable once for another two-year period. After four years, this contract can be concluded for an indefinite period in accordance with Service regulations for the locally recruited teachers in the European schools and the future needs of the school (cf. : article 12 of the Service regulations available on the following website: <https://www.eursc.eu/BasicTexts/2016-05-D-11-en-4.pdf>).

Your contract will also be linked to Luxemburgish law for social welfare and pensions.

- Starting day: 01/09/2019;
- Availability: Candidates must be available for the school years 2019-2020 & 2020-2021;
- Gross salary: 61 699,68 € per year for a full-time post of 21 periods according to article 35 of Service regulations;
- Removal costs: the selected teacher will be entitled to reimbursement of their removal expenses according to articles 37 & 38 of Service regulations;
- Under certain conditions the school can pay an installation allowance equal to one month salary;
