- 16-21 weekly periods (45 minutes).

Profile

- Native English speaker or command of English at mother tongue level;
- University degree and authorization to teach English as a foreign language in the secondary school at all levels;
- Experience of teaching English as a foreign language at the secondary level;
- Knowledge of a second working language (French/German) is an asset;
- Ability to work in an international environment and to cooperate with colleagues and management.

Conditions

We offer a one-year contract under the Service regulations for the locally recruited teachers in the European schools. The contract may be prolonged according to the future needs of the school (the Service regulations available on the following website: https://www.eursc.eu/BasicTexts/2016-05-D-11-en-6.pdf).

Your contract will also be linked to Luxemburgish law for social welfare and pensions.

- Starting day: 01/09/2020;
- Availability: Candidates must be available for the school year 2020-2021;
- Gross salary: 88 323,48 € per year for a full-time post of 21 periods according to article 35 of Service regulations:
- Removal costs: the selected teacher will be entitled to reimbursement of their removal expenses according to articles 37 & 38 of Service regulations;
- Under certain conditions the school can pay an installation allowance equal to one month salary;
- School fees: a reduction in school fees shall be granted to the selected teacher during the period of his/her employment for any of his/her children enrolled in the European Schools. (Cf.: article 39 of the Service regulations).
