- Experience as teacher in the Primary school for at least three years
- Willingness to teach lessons at secondary school
- Good knowledge of at least one of the other working languages of the European School of Luxembourg II (French, German, English) is mandatory.
- Experience and qualification to teach to students with specific educational needs will be considered as an asset.
- The candidates will be motivated to work in a team together with the other teachers and pedagogical staff of the Nursery-Primary cycle.
- The candidates will be willing to acquire the necessary knowledge for the effective use of the European Schools' specific software.
- The candidates will have knowledge of the European School system and be motivated to work in a multilingual and multicultural environment.
- The candidates will have a strong sense of responsibility and an impeccable personal presentation.
- The candidate has to be an EU citizen or be in possession of an authorization to work in the Grand Duchy of Luxembourg at the time of the application.
